

BAC Resolution Declaring LCRB/SCB and Recommending The Award of Contract

WHEREAS, the **Local Government Unit of General Santos City (LGU-GSC)** advertised the Invitation to Apply for Eligibility and to Bid for bid number **20CB-GSC-033 (CATERING SERVICES)** in the website of **LGU-GSC** (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for 7 days;

WHEREAS, in furtherance with the pertinent provisions of RA 9184 to ensure transparency of the process, observers from the NGO, Chamber of Commerce and COA were invited to observe and witness the Submission and Opening of Bids, Bid Evaluation and Post-Qualification as scheduled but none of them attended the said proceedings;

WHEREAS, on January 28, 2020, the scheduled deadline for the Submission and Opening of Bids, the BAC received three (3) bid proposals from MT. SABRINA PANORAMIC VIEW & RESORT, INC., YOLACH'S VENUE and CIARA'S BALLOONS & PARTY NEEDS & CATERING SERVICES. During the preliminary examination of bids, the BAC checked the submitted documents against the checklist of required documents to ascertain if they are all present;

WHEREAS, the BAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 1st envelope containing the technical components from MT. SABRINA PANORAMIC VIEW & RESORT, INC., YOLACH'S VENUE AND CIARA'S BALLOONS & PARTY NEEDS & CATERING SERVICES for purposes of complying with all the requirements stated in the bidding documents and the provisions of RA 9184;

WHEREAS, the BAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 2nd envelope containing the financial component of MT. SABRINA PANORAMIC VIEW & RESORT, INC., YOLACH'S VENUE AND CIARA'S BALLOONS & PARTY NEEDS & CATERING SERVICES with its bid proposal as follows:



After validation and verification, the TWG determined that CIARA'S BALLOONS & PARTY NEEDS & CATERING SERVICES complied with the technical specifications and is responsive to all the legal requirements and conditions specified in the Bidding Documents.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



- c) To **RECOMMEND** for approval and award of contract by the **City Mayor** of the **Local Government Unit of General Santos City** the foregoing findings.


