The Local Government Unit of General Santos City, through the **2019 ANNUAL BUDGET: AO #14 AND SB #2, AO#12, 2018** intends to apply the sum of **TEN MILLION SEVEN HUNDRED FORTY EIGHT THOUSAND NINE HUNDRED FIFTY FOUR PESOS & 28/100 (P 10,748,954.28)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **20CW-GSC-013 OTHER STRUCTURES - CONSTRUCTION OF APARTMENT NICHE, INDIVIDUAL BONE CHAMBER AND COMMON BONE CHAMBER, ANTONIO C. ACHARON MEMORIAL PARK, BRGY. FATIMA, GENERAL SANTOS CITY**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of General Santos City now invites bids for the **20CW-GSC-013 OTHER STRUCTURES - CONSTRUCTION OF APARTMENT NICHE, INDIVIDUAL BONE CHAMBER AND COMMON BONE CHAMBER, ANTONIO C. ACHARON MEMORIAL PARK, BRGY. FATIMA, GENERAL SANTOS CITY**. **COMPLETION** of the Works is required within **152 Calendar Days** respectively. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Local Government Unit of General Santos City and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00PM except on holidays.

A complete set of Bidding Documents may be purchased by interested Bidders starting **January 30, 2020 12:00NN** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Seven Hundred Forty Eight Pesos & 95/100 Only (P 10,748.95)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The Local Government Unit of General Santos City will hold a Pre-Bid Conference on **February 5, 2020 2:00PM** at the address below, which shall be open only to all interested parties who have purchased the Bidding Documents.

All Bidding Documents must be in prescribed form. Bids must be delivered to the address below on or before **February 17, 2020 12:00NN** at **Bids and Awards Committee, City Engineer's Office, P. Acharon Blvd. Ext., Bula Road, Brgy. Bula, General Santos City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Post-Qualification: **February 25- March 2, 2020**
