INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR
20CW-GSC-022
ESTABLISHMENT OF ORGANIC TRADING POST CITY OF GENERAL SANTOS CITY

The Local Government Unit of General Santos City, through the DEPARTMENT OF AGRICULTURE (DA) - Fund Transfer and the LGU Counterpart intends to apply the sum of ONE MILLION SIX HUNDRED SEVENTY THOUSAND NINE HUNDRED THIRTY SIX PESOS AND 1/100 (P 1,670,936.01) being the Approved Budget for the Contract (ABC) to payments under the contract for the 20CW-GSC-022 ESTABLISHMENT OF ORGANIC TRADING POST CITY OF GENERAL SANTOS CITY. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of General Santos City now invites bids for the 20CW-GSC-022 ESTABLISHMENT OF ORGANIC TRADING POST CITY OF GENERAL SANTOS CITY. COMPLETION of the Works is required within 90 Calendar Days respectively. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from Local Government Unit of General Santos City and inspect the Bidding Documents at the address stated below during 8:00 AM to 5:00PM except on holidays.

A complete set of Bidding Documents may be purchased by interested Bidders starting June 12, 2020 12:00 PM from the stated address below after and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ONE THOUSAND SEVEN HUNDRED FIFTY PESOS AND 0/100 (P 1,750.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The Local Government Unit of General Santos City will hold a Pre-Bid Conference on June 19, 2020 2:00 PM at the address below, which shall be open only to all interested parties who have purchased the Bidding Documents.

All Bidding Documents must be in prescribed form. Bids must be delivered to the address below on or before July 1, 2020 12:00 PM at Bids and Awards Committee, City Engineer's Office, Jorge Royeca Blvd., Brgy. Bula, General Santos City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Post-Qualification: April 9, 2020 - July 15, 2020
