

BAC Resolution Declaring **SCRB** and Recommending The Award of Contract

RESOLUTION NO. 2020-01-014 Series of 2020

WHEREAS, the **Local Government Unit of General Santos City (LGU-GSC)** advertised the Invitation to Apply for Eligibility and to Bid for bid number **20CB-GSC-003 (PURCHASE OF OFFICE EQUIPMENT)** in the website of **LGU-GSC** (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for **7 days**;

WHEREAS, in furtherance with the pertinent provisions of RA 9184 to ensure transparency of the process, observers from the NGO, Chamber of Commerce and COA were invited to observe and witness the Submission and Opening of Bids, Bid Evaluation and Post-Qualification as scheduled but none of them attended the said proceedings;

WHEREAS, on **December 19, 2019**, the scheduled deadline for the Submission and Opening of Bids, the BAC received only one (1) bid proposal from **EMCOR, INC.** During the preliminary examination of bids, the BAC checked the submitted documents against the checklist of required documents to ascertain if they are all present;

WHEREAS, the BAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 1st envelope containing the technical components of from **EMCOR, INC.** for complying with all the requirements stated in the bidding documents and the provisions of RA 9184;

WHEREAS, the BAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 2nd envelope containing the financial component of **EMCOR, INC.** with its bid proposal as follows:

WHEREAS, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on **January 16, 2020** to **EMCOR INC**, being the **Single** Calculated Bid for item number **A1, A2, A3, A4 & B1**. After validation and verification, the TWG determined that **EMCOR INC** complied with the technical specifications and is responsive to all the legal requirements and conditions specified in the Bidding Documents.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To **RECOMMEND AWARD** the following item no/s **A1, A2, A3, A4 & B1** to **EMCOR INC**, as the **Single** Calculated and Responsive; and
- b) To **DECLARE** item no. **C1** as **FAILURE OF BIDDING** due to none of the bidders quoted for the said item and recommend same for re-bidding; and
- c) To **RECOMMEND** for approval and award of contract by the **City Mayor** of the **Local Government Unit of General Santos City** the foregoing findings.


