

## BAC Resolution Declaring Lowest Calculated and Responsive Bidder and Recommending Approval

WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-030 CATERING SERVICES** in the **Local Government Unit of General Santos City** website ([www.gensantos.gov.ph](http://www.gensantos.gov.ph)), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

WHEREAS, in response to the said advertisements, **three (3)** suppliers purchased bid documents;

WHEREAS, **three (3)** bids offered were received by the BAC on **January 28, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids was conducted on **January 30, 2020** which resulted in the following:

WHEREAS, **YOLACH'S VENUE** was declared **non-responsive** for item no. **C1** as the end-user requires Within the City Proper Location only for the venue of activity;

WHEREAS, **CIARAS BALLOONS AND PARTY NEEDS AND CATERING SERVICES** was declared the second Lowest Calculated Bid for item no. **C1**;

WHEREAS, **YOLACH'S VENUE AND CIARA'S BALLOONS & PARTY NEEDS AND CATERING SERVICE** were declared **non-responsive** for item no. **RF1** since the bidders failed to comply with the end-user requirements within the City Business District for the venue of activity. And must have an elevator /lift for the SC & PWD and hotel ambiance with parking area. As per TWG evaluation the city proper means having the minimum fare of eight to Ten pesos only (P8.00 – 10.00);

WHEREAS, **KAINAN NI INAY JULITA** was quoted higher than ABC for item no. **RF1**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the eligible bidders with the Lowest Calculated Bid evaluated by **NANCY T. BURLAZA,MPA** and verified correct by **ATTY. ROSENDO A. ROQUE**, their bids have been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To **RECOMMEND AWARD** item no/s A1, A3, A4, A5, B1, D1 & D2 to **KAINAN NI INAY JULITA** with the **Lowest Calculated and Responsive Bid**;
- b) To **RECOMMEND AWARD** item no/s A2, D3, E1 & E2 to **YOLACH'S VENUE** with the **Lowest Calculated and Responsive Bid**;


