WHEREAS, **ACE MEDICAL SOLUTIONS, INC.** is the Single Calculated Bidder for items no. **23**; but declared **post-disqualified** because the attached Certificate of Product Registration (CPR) does not conform with the required specification, the requirement is 400mcg/tab but the offer is 200mcg/tab;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **ACE MEDICAL SOLUTIONS, INC.** with the Single Calculated Bid for item nos. **1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 15, 16, 17, 20, 25, 26, 27, 30, 31, 32, 33, 34, 35, 36, 37, 38, 40 & 42** and evaluated by **MR. 


- c) To recommend for approval/ award by the **City Mayor** of the **Local Government Unit of General Santos City** the foregoing findings.


