WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-208 PURCHASE OF ANIMAL FEEDS FOR CITY VET (RE BID)** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

WHEREAS, in response to the said advertisements, **One (1)** suppliers purchased bid documents;

WHEREAS, **One (1)** bid offered was received by the BAC on **April 7, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids was conducted on **April 23, 2020** which resulted in the following:

WHEREAS, **PACIFICA AGRIVET SUPPLIES INC.** was declared **non-responsive** during the bid evaluation since the submitted Omnibus Sworn Statement & Bid Securing Declaration were not notarize;

WHEREAS **PACIFICA AGRIVET SUPPLIES INC.** was given five (5) calendar days to file a motion for reconsideration on April 23, 2020;

WHEREAS, the request for reconsideration by **PACIFICA AGRIVET SUPPLIES INC.** was granted by the committee since the city of General Santos was under enhance community quarantine (ECQ) during the opening of bids and all non-essential establishments such as law firm to notarize bidding documents and insurance company were temporally close;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **PACIFICA AGRIVET SUPPLIES INC.** with the Single Calculated Bid for item no/s **1, 2 & 3** and evaluated by **ENGR. JAMES A. BINAYAN** and verified correct by **ATTY. ROSENDO A. ROQUE**, the bid has been found to be responsive;
