

SBAC Resolution Declaring Single Calculated and Responsive Bidder and Recommending Approval

WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-047 PURCHASE OF SPORTS EQUIPMENT – NON-BALL GAMES (SEF)** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPSS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

WHEREAS, in response to the said advertisements, **one (1)** supplier purchased bid documents;

WHEREAS, **one (1)** bid offered was received by the BAC on **January 30, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids was conducted on **January 30, 2020** which resulted in the following:

WHEREAS, **ASEANA GENERAL MERCHANDISE** was declared **non-responsive** by TWG-ENGR. JOEL T. MATANGUIHAN for item no. **2** since the bidder **did not comply the specs forms for the badminton racket & portable badminton scoreboard** and the actual amount of racket based on the current market value only cost P2,000.00 but the bid offered is P5,745.00 which disadvantage to the Government;

WHEREAS, on February 20, 2020, during the SBAC meeting the members resolve to award item no. **2** to **ASEANA GENERAL MERCHANDISE** and found it to be responsive, as the evaluation and contract award will be undertaken on a per lot basis provided that the bidder's offer will not exceed the total amount of each item. The bidder also submitted a sample of badminton racket (YONEX) for further evaluation and found it to be complying to the required specifications;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **ASEANA GENERAL MERCHANDISE** with the Single Calculated Bid for items no/s **1, 2, 3, 4, & 5** evaluated by **MR. VINCE GERALD M. AMABLE** and **ENGR. JOEL T. MATANGUIHAN** and verified correct by **ATTY. ROSENDO A. ROQUE**, the bids have been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a. To **RECOMMEND AWARD** item no. **1, 2, 3, 4, & 5** to **ASEANA GENERAL MERCHANDISE** with the **Single Calculated and Responsive Bid**;
- b. To return to end-user item no. **6 & 7** due to time constrain to conduct re-bidding process;
- c. To recommend for approval/ award by the **City Mayor** of the **Local Government Unit of General Santos City** the foregoing findings.


