WHEREAS, in response to the said advertisements, **Two (2)** suppliers purchased bid documents;

WHEREAS, **Two (2)** bids offered were received by the BAC on **February 25, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluations of bids were conducted on **May 19, 2020** which resulted in the following:



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


