WHEREAS, in response to the said advertisements, **One (1)** supplier purchased bid documents;

WHEREAS, there was **NO QUORUM** on the scheduled bid opening on **February 25, 2020**;

WHEREAS, the opening of bids was moved on **March 03, 2020**, **one (1)** was received by the BAC on the said date and passed the preliminary examination of bids;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


