WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB GSC 602 PURCHASE OF AGRICULTURAL AND MARINE SUPPLIES FOR AGRI** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Calendar Nineteen (19) calendar days;

WHEREAS, in response to the said advertisements, **Three (3)** suppliers purchased bid documents;

WHEREAS, **Three (3)** bids offered were received by the BAC on **October 27, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bid was conducted on **November 10, 2020** which resulted in the following:

WHEREAS, **NORTHERN AGRO INC.** was the Lowest Calculated Bid for item no. **1**; but declared **non-responsive** because did not meet the required specification of end-user, the needed requirement for the said item is **85% to 90% fall Army Worn Resistant** but the offer of the bidder was **80% fall Army Worn Resistant**;

WHEREAS, **LDA AGRI MARKETING** was declared the **Second Lowest** Calculated for item no. **1**;

WHEREAS, **JTM AGROCHEM** was the Lowest Calculated Bid for item no. **5**; but declared **non-responsive** because did not meet the required specification of end-user;

WHEREAS, **LDA AGRI MARKETING** was declared the **Second Lowest** Calculated for item no. **5**;

WHEREAS, **NORTHERN AGRO INC.** quoted higher than ABC for item no. **8**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the eligible bidders and evaluated by **MS. NANCY T. BURLAZA, MPA** and **ENGR. JAMES A. BINAYAN** and verified correct by **ATTY. ROSENDO A. ROQUE**, their bids have been found to be responsive;






