## CONTRACT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of NOV 1-8 2020 2020, between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **UNITED COCONUT PLANTERS LIFE ASSURANCE CORP.** of *Makati City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF HEALTHCARE INSURANCE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINETEEN MILLION EIGHT HUNDRED NINETY SEVEN THOUSAND NINE HUNDRED NINETY THREE PESOS AND 01/100 (P 19,897,993.01 )** (hereinafter called "the Contract Price");
