

## BAC Resolution Declaring Single Calculated and Responsive Bidder and Recommending Approval

WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-612 PURCHASE OF OFFICE EQUIPMENT** in the **Local Government Unit of General Santos City** website ([www.gensantos.gov.ph](http://www.gensantos.gov.ph)), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

WHEREAS, in response to the said advertisements, **One (1)** supplier purchased bid documents;

WHEREAS, **One (1)** bid offered was received by the BAC on **October 15, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids was conducted on **October 22, 2020** which resulted in the following:

WHEREAS, **EMCOR INC.** was the Single Calculated Bid for item no. **B1**; but declared **non-responsive** because did not meet the required specification of end-user, the needed requirement for the said item **9,500KJ/(H) COLLING CAPACITY** but the offer was **9,200 KJ/(H)** and the bidders was given (3) three calendar days to file a motion for reconsideration but failed to do so;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **EMCOR INC.** with the Single Calculated Bid for item no/s **A1 & C1** and evaluated by **ENGR. HENDEN M. PANAYAMAN** and **ENGR. PATRICK M. AKIATAN** and verified correct by **ATTY. ROSENDO A. ROQUE**, the bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To **RECOMMEND AWARD** item no/s. **A1 & C1 EMCOR INC.** With the **Single Calculated and Responsive Bid**;
