



CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **EMCOR, INC.** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF INFORMATION TECHNOLOGY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED PESOS ONLY (P 965,500.00)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
