The **Local Government Unit of General Santos City of General Santos City**, through the **TRUST FUND & GENERAL FUND – CONTINUING APPROPRIATIONS** intends to apply the sum of **EIGHTY TWO MILLION FOUR HUNDRED FIFTY NINE THOUSAND EIGHT HUNDRED SIXTY NINE PESOS AND 0/100 (P 82,459,869.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **2FB-21NCW-GSC-001 HOSPITALS & HEALTH CENTERS (DESIGN AND BUILD: SPECIAL CARE COMPLEX AT DR. JORGE P. ROYECA CITY HOSPITAL, BARANGAY LAGAO, GENERAL SANTOS CITY)** . Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Local Government Unit of General Santos City** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM except on holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 29, 2021 12:00 NN** from given address **below**.
6. The **Local Government Unit of General Santos City** will hold a Pre-Bid Conference on **February 5, 2021 2:00 PM** at the address stated below, which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below or online/electronic submission on or before **February 12, 2021 12:00 NN**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **February 12, 2021 2:00 PM** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
