WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-298 PURCHASE OF TOOLS AND MATERIALS FOR ROBOTICS** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Nineteen (19) calendar days;

WHEREAS, in response to the said advertisements, **Two (2)** suppliers purchased bid documents;

WHEREAS, **Two (2)** bids offered were received by the BAC on **July 02, 2020** but only **one (1)** passed the preliminary examination of bids;

WHEREAS, **ZERO KELVIN** was declared non-responsive during the opening of bids because the submitted Certificate of PHILGEPS Registration was under **Red Membership**;

WHEREAS, **ZERO KELVIN** submitted a letter of explanation for item no. 1 stating delay in submission of Certificate of PHILGEPS Registration (Platinum Membership);

WHEREAS, **LETTER OF EXPLANATION** submitted by **ZERO KELVIN** was **DENIED** by the BAC-MEMBER dated July 02, 2020 the required Philgeps Registration for the said project was a Platinum Membership;

WHEREAS, the detailed evaluation of bids was conducted on **July 09, 2020** which resulted in the following:




