



CONTRACT AGREEMENT

THIS AGREEMENT made this 22nd day of December 2020 between the LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY, Philippines (hereinafter called "the Entity") of the one part, and BOLTSMANN TRADING of Davao City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., PURCHASE OF GENERAL MERCHANDISE and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Fifteen Thousand Six Hundred Fifty One Pesos and 11/100 (P 115,651.11) (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract; and
- (f) the Entity's Notification of Award.
