



CONTRACT AGREEMENT

THIS AGREEMENT made this DEC 29 2020 day of 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY, Philippines** (hereinafter called "the Entity") of the one part, and **DRU CONSTRUCTION of General Santos City, Philippines** (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **HEAVY EQUIPMENT RENTALS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED THOUSAND PESOS ONLY (P700,000.00)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (f) the Entity's Notification of Award.
