



CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **A & L RABBI ADS & CRAFTS** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF T SHIRTS AND TOKENS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED SIXTY ONE THOUSAND SEVEN HUNDRED SIXTY PESOS ONLY (P 161,760.00)** (hereinafter called "the Contract Price");
