



CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of DEC 29 2020 2020 between the LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY, Philippines (hereinafter called "the Entity") of the one part, and **VELIAN AND R ENTERPRISE** of *Manila, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF ENGINE OIL** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED TWO THOUSAND NINE HUNDRED SIXTY PESOS ONLY (102,960.00)** (hereinafter called "the Contract Price");
