CONTRACT AGREEMENT

THIS AGREEMENT made this DEC 29 2020 day of 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **SEAMALL PETRON SERVICE STATION** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF DIESEL AND GASOLINE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX HUNDRED FORTY ONE THOUSAND NINE HUNDRED EVENTY FOUR PESOS 80/100 ONLY (P 641,974.80)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (f) The Entity's Notification of Award.
