



CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **CARESYSTEM TECHNOLOGY SOLUTION CO., INC.** of General Santos City *Philippines* (hereinafter called "the Supplier") of the other part;
