CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **TWIN-CIRCA MARKETING** of Polomolok South Cotabato, *Philippines* (hereinafter called "the Supplier") of the other part;
