



## CONTRACT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **ECE MARKETING** of *Davao City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF DRUGS & MEDICINES FOR POP** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED THIRTY TWO THOUSAND TWO HUNDRED FIFTY TWO PESOS AND 50/100 (P 132,252.50)** (hereinafter called "the Contract Price");

  - (f) the Entity's Notification of Award.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
