



## CONTRACT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of DEC 29 2020 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **EMCOR, INC.** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF OFFICE EQUIPMENT (RE-BID)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO HUNDRED NINE THOUSAND PESOS ONLY (P 209,000.00)** (hereinafter called "the Contract Price");
