

## BAC Resolution Declaring Single Calculated and Responsive Bidder and Recommending Approval

WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB GSC 509 PURCHASE OF OFFICE EQUIPMENT** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisements, **One (1)** supplier purchased bid documents;

WHEREAS, **One (1)** bid offered was received by the BAC on **August 25, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bid was conducted on **September 01, 2020** which resulted in the following:

WHEREAS, **EMCOR INCORPORATED** was declared the Single Calculated Bidder for no. A3 and A4 for Full HD 50" LED Television but offered different price quotation with almost the same specifications which is not allowed in RA 9184, as the government will award to responsible bidder whose offer conforming to the minimum required specifications and price quotation whichever is advantageous to the government;

WHEREAS, **EMCOR INCORPORATED** submitted a letter on December 3, 2020 informing the BAC that they would conformed to offer lower price offer for item no. A3 and A4;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the eligible bidders **EMCOR INCORPORATED** with the Single Calculated Bid for item no/s **A1, A2, A3 & A4** and evaluated by **ENGR. HENDEN M. PANAYAMAN** and **MS. NANCY T. BURLAZA, MPA** and verified correct by **ATTY. ROSENDO A. ROQUE**, the bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To **RECOMMEND AWARD** item nos. **A1, A2, A3 & A4 EMCOR INC.** with the **Single Calculated and Responsive Bid**;
