CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of ~~FEBRUARY~~ 13, 2021 2020 between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **EMCOR, INC.** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PURCHASE OF IT EQUIPMENT** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FOUR HUNDRED FORTY SIX THOUSAND EIGHT HUNDRED PESOS ONLY (P 446,800.00)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
