NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To **RECOMMEND AWARD** item no/s **B1 & C1 EMCOR INC.** With the **Single Calculated and Responsive Bid**;
