NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a. To **RECOMMEND AWARD** item no. **R1** to **SKO TRADING** with the **Single Calculated and Responsive Bid**;
