WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **20CB-GSC-641 PURCHASE OF BRAND NEW MOTORCYCLES** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:




