## CONTRACT AGREEMENT

THIS AGREEMENT made this 3RD day of FEBRUARY 2021, between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **VENUE 88 RESORT & EVENTS PLACE CORP.** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **CATERING SERVICES** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Six Hundred Seventy Two Thousand Three Hundred Fifty Pesos Only (P 672,350.00 )** (hereinafter called "the Contract Price");

  - (f) the Entity's Notification of Award.
