WHEREAS, the **Local Government Unit of General Santos City** advertised the Invitation to Bid for **21CB-GSC-010 PURCHASE OF CATERING SERVICES** in the **Local Government Unit of General Santos City** website (www.gensantos.gov.ph), the G-EPSC and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for Seven (7) calendar days;

WHEREAS, in response to the said advertisements, **Two (2)** suppliers purchased bid documents;

WHEREAS, **Two (2)** bids offered received by the BAC on **December 15, 2020** and passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids was conducted on **December 15, 2020** which resulted in the following:

VENUE 88 RESORTS AND EVENTS PLACE CORPORATION	A1, A4, A5, A6, A7, A8, and B1
RED TREE EVENTS PRODUCTION	A2, A3, and B1

WHEREAS, for item no. **B1** were quoted by **RED TREE EVENTS PRODUCTION** and **VENUE 88 RESORTS AND EVENTS PLACE CORPORATION** with the same price quotation, however, **RED TREE EVENTS PRODUCTION** was declared **non-responsive** because the Manpower Requirements & After Sales (Warranty) were unsigned or have no signature and the bidder was given Three (3) calendar days to file motion for reconsideration (MR) but failed to do it; hence, for award to **VENUE 88 RESORTS AND EVENTS PLACE CORPORATION**;

WHEREAS, **RED TREE EVENTS PRODUCTION** was the Lowest Calculated Bid for item no/s. **A2 & A3** but declared **non-responsive** during the bid evaluation because the Manpower Requirements & After Sales (Warranty) were unsigned or have no signature and the bidder was given three (3) calendar days to file a Motion for Reconsideration (MR) But failed to do so;

WHEREAS, **VENUE 88 RESORTS AND EVENTS PLACE CORPORATION** was declared the **Second Lowest** Calculated for item no/s. **A2 & A3**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the eligible bidders with the Lowest Calculated Bid as evaluated by **ENGR. JAMES A. BINAYAN** and **RODANTE A. LIM, CGM** verified correct by **ATTY.ROSENDO A. ROQUE**, their bids have been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a. To recommend the award of item/s no. **A1, A2, A3, A4, A5, A6, A7, A8, and B1** to **VENUE 88 RESORTS AND EVENTS PLACE CORPORATION** for being the bidder with the **Lowest Calculated and Responsive Bid**;
- b. To recommend for approval/award by the City Mayor of the Local Government Unit of General Santos City the foregoing findings.


