CONTRACT AGREEMENT

THIS AGREEMENT made this 13TH day of FEBRUARY 2021, between the **LOCAL GOVERNMENT UNIT OF GENERAL SANTOS CITY**, Philippines (hereinafter called "the Entity") of the one part, and **CIARA'S BALLOONS & PARTY NEEDS & CATERING SERVICES** of *General Santos City, Philippines* (hereinafter called "the Supplier") of the other part;

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **CATERING SERVICES** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **ONE HUNDRED EIGHT THOUSAND PESOS ONLY (P108,000.00)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract; and
- (f) the Entity's Notification of Award.
