**IMPROVEMENT OF ROAD SECTION AT CENTRAL BUSINESS DISTRICT, BRGYS. DAD. EAST AND SOUTH, GENERAL SANTOS CITY**

1. The **Local Government Unit of General Santos City of General Santos City**, through the **20% LDF ANNUAL BUDGET 2021** intends to apply the sum of **ELEVEN MILLION NINE HUNDRED NINETY NINE THOUSAND SEVEN HUNDRED SEVENTEEN PESOS AND 16/100 (P 11,999,717.16)** being the Approved Budget for the Contract (ABC) to payments under the contract for **21CW-GSC-011 IMPROVEMENT OF ROAD SECTION AT CENTRAL BUSINESS DISTRICT, BRGYS. DAD. EAST AND SOUTH, GENERAL SANTOS CITY**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of General Santos City** now invites bids for the above Procurement Project. Completion of the Works is required **120 Calendar Days respectively**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Local Government Unit of General Santos City** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM except on holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **April 14, 2021 12:00 NN** from given address **below** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of amount of **ELEVEN THOUSAND NINE HUNDRED NINETY NINE PESOS AND 72/100 (P 11,999.72)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
6. The **Local Government Unit of General Santos City** will hold a Pre-Bid Conference on **April 21, 2021 2:00 PM** at the address **stated below**, which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below or online/electronic submission on or before **May 3, 2021 12:00 NN**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **May 3, 2021 2:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.


