WHEREAS, the **Local Government Unit of General Santos City (LGU-GSC)** advertised the Invitation to Apply for Eligibility and to Bid for bid number **209CB-GSC-002 (STRUCTURED LAN INSTALLATION FOR NEGOSYO CENTER)** in the website of **LGU-GSC** (www.gensantos.gov.ph), the G-EPS and conspicuous places at the premises of the **Local Government Unit of General Santos City** continuously for 7 days;

WHEREAS, in furtherance with the pertinent provisions of RA 9184 to ensure transparency of the process, observers from the NGO, Chamber of Commerce and COA were invited to observe and witness the Submission and Opening of Bids, Bid Evaluation and Post-Qualification as scheduled but none of them attended the said proceedings;

WHEREAS, on December 19, 2019, the scheduled deadline for the Submission and Opening of Bids, the SBAC received only one (1) bid proposal from COLUMBIA COMPUTER CENTER, INC-DAVAO. During the preliminary examination of bids, the BAC checked the submitted documents against the checklist of required documents to ascertain if they are all present;

WHEREAS, the SBAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 1st envelope containing the technical components of from COLUMBIA COMPUTER CENTER, INC-DAVAO for complying with all the requirements stated in the bidding documents and the provisions of RA 9184;

WHEREAS, the SBAC using a non-discretionary "pass/fail" criterion found and rated "PASSED" the 2nd envelope containing the financial component of COLUMBIA COMPUTER CENTER, INC-DAVAO with its bid proposal as follows:
